Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project Kosh (Revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission.

Bids must be valid for a period of 90 days from the date of bid submission. All bids must be accompanied by a bid security of amount mentioned above, **valid 30 days beyond Bid validity**. 5. Bids received after the deadline of the submission will be rejected. Bids will be opened in the presence of the Bidders representatives who choose to attend at **Dhangadhi Sub-Metropolitan City** at 14:00 Hours on 31st days from publication date.
6. If the last day for purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day. In such a case the bid security validity shall be recognized with effect from the original bid submission deadline.
7. Bank Guarantee issued by any finance company in any form will not be accepted.
8. Bids should comply in all respects with the Instructions to Bidder included in the Bid Document. Non Compliance with this instructions will result in disqualification.
9. In the case of discrepancies or error in bid documents, bid notice or any other documents, Dhangadhi Sub-Metropolitan City reserves the right to amend and correct at any time.
10. If bidders are not manufacturer, they must submit sole authorization letter from the manufacturer or from the authorized distributor of the manufacturer.
11. The supplier shall provide a performance security of 5% of the contract price in NRS issued by "A" class commercial bank located in Nepal, and shall be valid at least 30 days from the date of bid submission.
12. The purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
