- 4. Sealed bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali by hand/courier on or before 12:00 Hours on 16th Days from Publication Date. Bids received after this deadline will be rejected.
- 5. Bids will be opened in the presence of the Bidders representatives who choose to attend at *Dhangadhi Sub-Metropolitan City* at 13:00 Hours on 16th days from Publication Date. Bids must be valid for a period of 45 (Fourty Five) after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid.
- 6. If the last day for purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- 7. Bids should comply in all respects with the Instructions to Bidder included in the Bid Document. Non compliance with this instructions will result in disqualification.
- 8. In the case of discrepancies or error in bid documents, bid notice or any other documents, Dhangadhi Sub-Metropolitan City reserves the right to amend and correct at any time.
- 9. If bidders are not manufacturer, they must submit sole authorization letter from the manufacturer or from the authorized distributor of the manufacturer.
