Or Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for from PPMO's e-GP system [www.bolpatra.gov.np](http://www.bolpatra.gov.np). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Sanchit Kosh account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bid.

4. Pre-bid meeting shall be held at Dhangadhi Sub-Metropolitan City, Kailali at 12:00 pm on 2075/07/30 (Nov. 16<sup>th</sup>, 2018)

Sealed or electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali by hand/courier or through PPMO's e-GP system [www.bolpatra.gov.np](http://www.bolpatra.gov.np) on or before 12:00 Noon on 2075/08/11 (Nov. 27<sup>th</sup>, 2018). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2075/08/11 (Nov. 27<sup>th</sup>, 2018) at the office of Dhangadhi Sub-Metropolitan Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in case of e-bid, amounting to a minimum of 2.5% of the Total Project Cost including VAT, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity shall be recognized with effect from the original bid submission deadline.
8. In case of discrepancy or error in Tender notice, bid document and other document of Construction of Ward Office Building mentioned above reserves right to amend, correct or modify the same at any time. Such amendment and correction shall be published in the national daily newspaper, notice board of the Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali.
