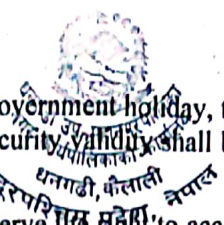

4. Pre-bid meeting shall be held at Dhangadhi Sub-Metropolitan City, Kailali at 12:00 pm on 2077/06/02 (September 18th, 2020).
5. Electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on 2077/06/13 (September 29th, 2020). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2077/06/13 (September 29th, 2020) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
