- 4. Pre-bid meeting shall be held at Dhangadhi Sub-Metropolitan City, Kailali at 12:00 pm on 2076/03/06 (June. 21<sup>th</sup>, 2019)
- Electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali through PPMO's e-GP system <u>www.bolpatra.gov.np/egp</u> on or before 12:00 Noon on 2076/03/22(July. 7<sup>th</sup>, 2019).Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2076/03/22(July. 7<sup>th</sup>, 2019) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security in pdf format amounting to 3,00,000.00, which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
