 - The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2078/02/02 (16th May 2021) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
