4. Pre-bid meeting shall be held at Dhangadhi Sub-Metropolitan City, Kailali at 12:00 pm on 2076/05/12 (August 29th, 2019)

5. Sealed or electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on 2076/05/20 (Sept 6th, 2019). Bids received after this deadline will be rejected.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2076/05/20 (Sept 6th, 2019) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 2,00,000/- (Two Lakhs Only)**, which shall be valid for 30 days beyond the validity period of the bid.

7. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.

8. Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali, reserve the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
