



## Dhangadhi Sub-Metropolitan City Office of the Municipal Executive Dhangadhi, Kailali

Dhangadhi Sub-Metropolitan City, Office of the Municipal Executive invites sealed bids from eligible bidders for Construction of 1 Span (1X20m) RCC Motorable Bridge at Kailali Khola, Ward No. 4 & 13 Construction under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: [NRs. 60 Million]
- Minimum Work experience of similar size and nature: [1 Project of about NRs. 40 Million]
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

4. Bidder May chooses to submit their bid electronically and may download/submit the bidding documents from PPMO's e-GP system <a href="https://www.bolpatra.gov.np/egp">ww.bolpatra.gov.np/egp</a>. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Sanchit Kosh (Revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

5. Pre-bid meeting shall be held at Dhangadhi Sub-Metropolitan City, Kailali at 12:00 pm on 2076/03/05 (June 20th, 2019)

Sealed or electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali by hand/courier or through PPMO's e-GP system <a href="https://www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before 12:00 Noon on 2076/03/20 (July 5th, 2019). Bids received after this deadline will be rejected.

7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2076/03/20 (July 5<sup>th</sup>, 2019). at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of NRs. 11,20,000/- (Eleven Lakhs Twenty Thousand Only), which shall be valid for 30 days beyond the validity period of the bid.

8. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be insidered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original submission deadline.

9. Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali, reserve the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.

In case of discrepancy or error in Tender notice, bid document and other document of Construction of 1 Span (1X20m) RCC Motorable Bridge at Kaillai Khola, Ward No. 4 & 13 projects reserves right to amend, correct at any time. Such amendment and correction shall be published in the national daily newspaper, notice board of the Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali.
