- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at the date mentioned above at the office of Dhangadhi Sub-Metropolitan City Office. Dhangadhi, Kailali. Bids must be valid for a period of 45 (Fourty Five) days from bid submission date and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity
 and bid security validity shall be recognized with effect from the original bid submission deadline.
