5. Electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on 2076/10/12 (January 26th, 2020). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2076/10/12 (January 26th, 2020) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **3,70,000/- (Three Lakh Seventy Thousand Only)**, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
