- The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2076/10/12 6. (January 26th, 2020) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of NRs. 3,70,000/- (Three Lakh Seventy Thousand Only), which shall be valid for 30 days beyond the validity period of the bid.
