A complete set of Bidding Documents may be purchased from the Dhangadhi Sub- Metropolitan City office by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs 3,000/- till 29th - Apr - 2021 (2078/01/16 BS) during office hours.
4. Pre-bid meeting shall be held at Dhangadhi Sub-Metropolitan City, Office of the Municipal Executive at 20th - Apr - 2021 (2078/01/07 BS) at 12:00 Noon.
5. Sealed bids must be submitted to the Dhangadhi Sub- Metropolitan City on or before 12:00 Noon on 30th - Apr - 2021 (2078/01/17 BS). Bids received after this deadline will be rejected.
6. The Bids shall be opened in presence of Bidders' representatives who choose to attend on 2:00 PM on 30th - Apr - 2021 (2078/01/17 BS) at the office of Dhangadhi Sub- Metropolitan City. Bids must be valid for a period of 90 (Ninety) days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of Nrs. 90,000 (Ninty Thousand only), which shall be valid for minimum 30 days beyond the bid validity period.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali, reserve the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
