4. Electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 Noon on 2<sup>nd</sup> May 2024 (2081/01/20 BS). Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:30 pm on 2<sup>nd</sup> May 2024 (2081/01/20 BS) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
