The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:30 pm on 12<sup>th</sup> April 2024 (2080/12/30 B.S.) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 45 (Forty Five) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of NRs. 50,000/- which shall be valid for 30 days beyond the validity period of the bid.
