4. Sealed Quotations must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali by hand/courier on or before 12:00 Noon on Sixteenth (16) Day from the Date of Notice Published. Quotations /Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 Hours on Sixteenth (16) Day from the Date of Notice Published for Sealed Quotation at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 45 (Ninety Days) after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid.
