4. Pre-bid meeting shall be held at Dhangadhi Sub-Metropolitan City, Kailali at 12:00 pm on 2076/07/22 (November 8th, 2019)

5. Electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on 2076/07/29 (November 15th, 2019). Bids received after this deadline will be rejected.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2076/07/29 (November 15th, 2019) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 2,15,000/- (Two Lakhs Fifteen Thousand Only), which shall be valid for 30 days beyond the validity period of the bid.

7. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.

8. Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali, reserve the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
