4. Sealed or electronic bids must be submitted to the office Dhangadhi Sub-Metropolitan City, Dhangadhi, Kailali by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00Hrs on 2075/08/20 (6th Dec 2018). Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs on 2075/08/20 (6th Dec 2018) at the office of Dhangadhi Sub-Metropolitan City. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **1,50,000/-**, which shall be valid for 30 days beyond the validity period of the bid.
